Unisem Reports Revenue of RM382.3 million (approx. U\$\$89.7 million) and Net Profit of RM40.9 million (approx. U\$\$9.6 million) for Third Quarter 2017

**Kuala Lumpur, 1 November 2017 –** Unisem (M) Berhad today announced results for the third quarter ended 30 September 2017 (**3Q17**).

Unisem recorded a consolidated revenue and net profit of RM382.3 million (approx. US\$89.7 million) and RM40.9 million (approx. US\$9.6 million) respectively for 3Q17, these represent increase of 18.8 percent and 5.5 percent as compared to the revenue and net profit achieved in the corresponding quarter ended 30 September 2016 (3Q16) respectively.

For the nine months period ended 30 September 2017 (9m17), the Group recorded revenue and net profit of RM1.1 billion (approx. US\$255.1 million) and RM128.8 million (approx. US\$29.7 million) respectively, these represent increase of 15.4 percent in revenue and 15.2 percent in net profit as compared to the same period a year ago (9m16).

The increase in revenue and net profits for the current quarter and financial year to date was attributable to higher sales, improved average selling prices and the appreciation of USD/MYR exchange rate as compared to the prevailing rate in the corresponding quarter/period a year ago.

Group's earnings before interest, tax, depreciation and amortization (EBITDA) for 3Q17 came in at about RM87.4 million (approx. U\$\$20.5 million), EBITDA margin was about 22.9 percent. Equipment capacity utilization averaged at about 70 percent for the Group in 3Q17. Group's capital expenditure incurred in 3Q17 was about RM23.3 million (approx. U\$\$5.5 million), principally for purchase of equipment for advanced packaging activities.

Commenting on the outlook of the Group, Mr. John Chia Sin Tet, the group managing director said, "We expect the performance of the Group to remain satisfactory till the end of the financial year"
